General Terms & Conditions:

- 1. The quotations received after 14th May 2024 up to 3:00 PM or unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay, this Institute will not be responsible. The offer Submitted by/through Fax/Email shall not be considered and no correspondence will be entertained in this matter.
- 2. Quotations must be in the enclosed prescribed format duly signed by the Proprietor/Partner/Director or their Authorized Representative, in case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation. Quotations must be dropped in the "Quotation Box" located in the Administration Block of AIIMS, Jodhpur. The quotation must be in a sealed envelope super scribed with the inquiry number.
- 3. Rates must be quoted in "Indian Rupees," and the bidder should give rates, showing taxes and levies, if any, in the prescribed format. Quotations not conforming to these requirements shall be rejected, and no correspondence will be entertained whatsoever.
- 4. No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
- 5. The rates quoted must be valid for 90 days minimum from the date of opening of the quotation.
- 6. L1 will be decided on a composite basis. Becoming L1 will not be the criteria for awarding of work unless the rates are reasonable & justified.
- 7. RTGS/NEFT details need to be furnished by the bidder with the quotation in Annexure A.
- 8. Quotations qualified by such vague and indefinite expressions as "subject to prior confirmation," "subject to immediate acceptance," etc., will be treated as vague offers and rejected accordingly. Any conditional quotation shall be rejected summarily.
- 9. The time allowed to complete the work of providing and fixing as per details mentioned in Annexure A is 10 days from the date of issue of the award letter.
- 10. Contractor shall be fully responsible for any damages caused to govt. property or allotter's property by his or his labour in carrying out the work and shall be rectified by the contractor at his own cost.
- 11. Disputes: In the event of any dispute or disagreement arising between the contractors and any other department of AIIMS Jodhpur with regard to the interpretation of the "Terms & Conditions" of this inquiry, the same shall be referred to the Executive Director, AIIMS Jodhpur whose decision will be final and binding. Any disputes are subject to the exclusive jurisdiction of a competent court and forum in Jodhpur, Rajasthan, India only.
- 12. The Arbitration shall be held in accordance with the provision of the Arbitration and Conciliations Act, 1996, and the venue of arbitration shall be at Jodhpur. The decision of the Arbitrator shall be final and binding on both the parties.
- 13. AIIMS, Jodhpur reserves the right to increase or decrease the quantity and/or amount of work.
- 14. AIIMS, Jodhpur reserves the right to reject any quotation or part or the whole of the inviting quotation process without assigning any reason. The decision of the AIIMS, Jodhpur, will be final in this regard.

15. The contract shall be governed by laws and procedures established by Govt. of India within the framework of applicable legislation and enactment made from time to time concerning such commercial dealings/processing.

Special Terms & Conditions:

- 1. Bidder must quote rate in Price Bid Form provided in Annexure A.
- 2. It is the responsibility of the contractor to provide and fixing of flooring at the required location, complete with transportation, labor including connection, PVC welding, etc., as required, and nothing shall be paid extra in this account.
- 3. It is the responsibility of the contractor to watch and ward their material tools and flooring, etc., during installation at the required location. AIIMS Jodhpur shall not be responsible for damage /missing of any item, and nothing shall be paid extra in this account.
- 4. The contractor shall be fully responsible for the safety of all labour/employees employed on the work.
- 5. The contractor shall have to arrange all types of tools and special welding and glue, etc., at his own cost as required to carry out work for which nothing extra shall be paid to the contractor by the department.
- 6. There shall be no liability on the AHMS Jodhpur to pay any compensations arising out of any labour dispute or accident etc at site.
- 7. Workers engaged by the contractor for the execution of work shall be the liability of the contractor.
- 8. Any damage done by the contractor or his workmen to any existing work during the course of execution of the work shall be made good by him at his own cost.
- 9. The Contractor shall clear the site thoroughly of all rubbish, etc., left out of his materials immediately on completion of the work and properly clean the site around the building to the satisfaction of the Engineering -in-charge, otherwise, the site will be cleared by the department at his risk & cost to remove and clean the site.
